The Program and our collection and use of your personal information is also subject to our Privacy Policy. By contacting us, you are agreeing to participate in the Program, you accept and agree to these Mobile Messaging Terms and our Privacy Policy.

Program Description

We may send promotional and transactional mobile messages in various formats through the Program. Transactional messages relate to an existing or ongoing transaction and may include service updates, reminders and other transaction related information. Mobile messages may be sent using automated technology, including an auto dialer, automated system, or automatic telephone dialing system. Message frequency will vary. You agree that we, our affiliates, and any third-party service providers may send you messages regarding the foregoing topics or any topic and that such messages and/or calls may be made or placed using different telephone numbers or short codes, except in connection with marketing purposes.
